REPORT To The HONOURABLE  
The MINISTER Of The INTERIOR.

Montreal, 4th July, 1887.

To the

Honourable Thomas White, M. P.,  
Minister of the Interior,  
Ottawa.

Sir,

We have the honour

to report that in accordance with the Order in  
Council of the 25th February, 1886, appointing us  
Commissioners, for the purpose of examining into  
and hearing evidence, concerning any claim for com-  
pensation for loss arising out of the late outbreak  
enc.  
in the North West Territories, and on receipt of the  
Letter of Instructions from your Deputy Minister  
dated Ottawa, 26th February, 1886, addressed to J.  
Alphonse Ouimet, Esq., Chairman of the Commission,  
who immediately communicated the same to the other  
Commissioners, we proceeded at once to the North  
West.

We went in the first place to Prince Albert,  
at which point the Commission had its first meeting  
and organized for the discharge of its duties.

It was then decided, in order the better to

carry

carry on the work and to give the greatest possible convenience and facilities to the claimants, to divide those parts of the North West Territories, that had been in a disturbed condition, into four (4) Districts, and to appoint a central place in each District in which to hold sittings of the Commission, receive claims and take sworn evidence thereon.

- The divisions were then made as follows, Viz:
- 1st - The Prince Albert District, with Prince Albert as place of sitting.
  - 2nd - The Battleford District, with Battleford as place of sitting.
  - 3rd - The Calgary District, with Calgary as place of sitting.
  - 4th - The Qu'Appelle District, with Qu'Appelle as place of sitting.

Notices in the Public Press and by Posters were at once given in the localities affected by this arrangement of the work, and at a later date of the sittings at each point were also publicly announced through the Press and by Posters.

The localities situate in each of the Districts just mentioned are enumerated in Statement A, for-

forwarded herewith, and according to the same statement the total number of claims of all classes in each of these Districts is as follows :-

1st	The Prince Albert District	577
2nd	The Battleford District	147
3rd	The Calgary District	127
4th	The Qu'Appelle District	74

A portion of these claims have only been received from July, 1886, to date, during which period the Commission sat continuously.

We would call your attention here to the fact that although in some of the localities from which claims have been received, there have been no actual fighting, still the entire country had been disturbed and the Law set at defiance in many points.

The hostile attitude assumed by different Indian tribes and other sympathizers with the insurgents made it an absolute necessity for many settlers to leave their homes and rally together in central localities for the protection of life and such property as they were able in their necessarily hurried movements to take with them.

In many instances property of various kinds had to be abandoned by these people flying for refuge

refuge, as they were compelled to do at a very short warning.

In addition to the enquiries carried on at the points named, your Commissioners also received evidence at Winnipeg and at Montreal from such claimants as on account of absence and removal were unable to present their cases in the District in which the loss occurred.

We commenced at once at Prince Albert to receive claims from that District, to take the sworn evidence offered in support of the claims presented,

which evidence is on record in each case and is transmitted herewith for your information, with our reports annexed.

The same procedure was also adopted for the Battleford, Calgary and Qu'Appelle Districts, as rapidly as such points could be reached and the claims, records and reports are also forwarded herewith from these several Districts.

In dealing with the claims we acted in the most liberal manner possible, but in many cases we were obliged to reduce the prices charged, because of the fact that we found that claimants charged very different amounts for similar articles lost at the same time and place, and consequently from all

the

the evidence adduced we found it necessary to make the alterations referred to.

The claims have been divided into Classes, for more convenient reference, as follows :-

Class A. Comprises awards for unavoidable direct losses.

Class B. Comprises all claims for imprisonment by the Rebels.

Class C. Comprises all claims rejected because claimants were party to their own losses.

Class D. Comprises all avoidable losses and where claimants did not render assistance to Authorities.

Class E. Comprises claims rejected for lack of evidence and otherwise.

Class F. Comprises claims transferred to other Departments of the Government for settlement as not within scope of this Commission

The distribution of the claims into these Classes is shown in the Statement A before referred to.

We were the better able to decide on the claims before us, as we had acting under instructions, immediately at the suppression of the Rebellion,

visited

Visited the various points affected by the insurrection, and made ourselves familiar with the circumstances existing at the time the depredations were committed. The amounts claimed and allowed in the various Districts are as follows:-

The reductions made are largely composed of amounts charged in the claims for consequential damages, by the rejection of the claims of those who were party to their own losses, and of those who abandoned their property without assisting any local organization in its efforts for mutual protection of property.

In addition to the evidence on record, such merchants as saved their books submitted them for examination.

In conclusion we deem it only fair to Captain Geo. H. Young, Secretary of the Commission, to acknowledge

acknowledge the zealous and intelligent manner in  
which he has discharged his duties. All of which  
is respectfully submitted.
