Since the meeting can only take place in Quebec if someone at Laval agrees to organize it (Sandria cannot), the Executive will await the outcome of Sandria's inquiries and take the next appropriate steps [It was subsequently decided by that the Executive that the 2007 AGM/Conference will take place in Edmonton, Alberta, at the University of Alberta, on November 2nd-4th].

Fundraising

The new executive will consider possibilities for SSHRCC conference and publication funding. It was noted that conference funding may be applied for twice a year, with deadlines of November and May 1. It was noted that the publication funding is awarded on a three-year cycle and that the next opportunity for funding arises in 2007. Changes are currently being made by SSHRCC to both types of funding.

Recordings (David Gregory)

Oral report received. Due to a lack of funding last year, no projects were undertaken. However, the Recordings Committee will investigate possible collaborations with Folkways Alive and similar organizations.

Appointed Positions

It was decided that the executive would appoint an ICTM representative and Membership Secretary.

Mike MacDonald committed to work with the executive in order to develop and provide classroom and instructional support for members.

Treasurer's Report

The financial statements comprise a Balance Sheet and a Statement of Income and Expenses. The financial statements are unaudited. There were several notable financial events during this financial year.

First, the down side.

- Membership renewals, both individual and organisational, are down for the second year in a row. I estimate 200 paying memberships for the 2006-2007 financial year.
- Both the Journal and the Magazine appeared late, delaying membership and grant revenue. The Magazine did not do a double mailing, nor a double issue, as had been hoped for in last year's budget.
- The SOCAN grant for 2003 (\$1500) will not be arriving. We did not submit a report to them for that year.
- The SOCAN grant for 2005 (\$1000) has not yet arrived.
- One of the two GST rebates did not arrive during the financial year.

Second, the up side.

• We received an unbudgeted income of \$1130 from the New Westminster AGM (although that has already been spent by higher than budgeted publication expenses).

Third, the financially neutral side.

• We printed and mailed five Magazines during the financial year just ended and have thus caught up half of our backlog. In the coming financial year five Magazines would need to be printed and mailed in order to catch up completely. The budget (see below) has been designed to reflect this.

For the financial year 2006-2007 the following **budget** is proposed for administration and publications (that is, including neither the AGM nor the Mail Order Service, both of which are assumed to break even).

- Membership fees of \$8900 plus donations of \$250 plus SOCAN grants for 2006 of \$1000 plus single issue sales of \$50 plus GST rebate of \$200 plus fund-raising of \$100 gives us **income of \$10500**.
- Administration and general publication expenses \$1000. This leaves us \$9500 to spend.
- One 60 page Journal for December 2006, printing expenses \$1500 plus mailing expenses \$1050. This leaves us **\$6950** to spend.
- Four Magazines, all 40 pages, printing expenses \$3800. Assuming that the December issue is mailed with the Journal, mailing expenses of \$1890. This results in an **operating surplus of \$1260**.
- The fifth Magazine (40 pages) is treated as an extraordinary charge, rather than as a regular expense. Assuming that this Magazine can be mailed together with another Magazine at some time during the coming financial year, the cost of printing and mailing the additional Magazine is \$1370. I would also strongly recommend producing a double issue for an additional saving on printing costs.
- The opening balance of \$4120 plus the \$1000 SOCAN grant for 2005 in arrears plus \$100 GST rebate in arrears minus the extraordinary charge for the additional Magazine of \$1370 plus the operating surplus of \$1260 will leave us a closing balance of \$5110 plus the reserve account of \$1140. Based on cash flow projections for the next two years I recommend immediately moving an additional \$2000 to the reserve account to create a prudent financial reserve.
- If printing and postage costs are assumed to increase by 5% per year, and if paying memberships are assumed to decline by 10% per year, this gives operating **deficits** for the following three financial years of \$100, \$1400, and \$2600. The Society would use its financial reserve during 2009-2010 and would have a closing balance in 2010 of \$3400. This suggests that to avoid cash flow problems there may need to be a membership fee increase at the 2009 AGM.

Mail Order Service Report

This was another excellent year for sales at local Calgary folk clubs. Again, thanks go to the Calgary Folk Club, the Nickelodeon Music Club, the Rocky Mountain Folk Club, and Celtic Folk for allowing us to set up our table during the season. Thanks are also due to John Leeder, Marge Leeder, Rodger Leeder, Janet Sisson, Judy Breeze, Maureen Chafe, and George Smith for making the sales possible.

I am still looking for a distributor in the east who deals with many of the excellent east coast performers that we rarely (or never) see in this part of the country. Right now the only opportunity I have to get new items is by meeting the artists in person unless they have a distribution deal with Festival Distribution in Vancouver.

We also have an account with Smithsonian-Folkways but in the past the value of the dollar has made it difficult to justify bringing in Canadian archive material for resale here. We also have an account with a distributor for the Bear Family record label in Germany who have Stu Phillips ("A Journey Through the Provinces") and Lesley Schatz as part of their roster.

A few changes were made to the website during the year and I find now I have a bit of a back-log to get through, and many of the orders which came in have been filled. There is still the odd item that appears in the listings that we have not had for quite some time, even though I thought I had checked them all.

Postal increases appear to be on the horizon again, so adjustments may be needed to our rates. I would still like anyone who wants to order a cassette to contact me first to check on the rates. A single cassette in a padded envelope exceeds the Canadian first class measurements and must go as a parcel. This is not the case if the item is sent in a regular envelope.

I have not sent Zainab Haruna many changes for the website, but it seems that some of the files which were originally transmitted to her contained typos or obsolete prices, and we are still ferreting these out, or coming upon them accidentally. My thanks go to Zainab for the work she has done.

Canadian Folk Music: Editors' Report

Looking back over the issues published in the last twelve months, we see that we have sent four to the printers since writing our last report in October 2005. The first two of these were published last winter and completed, a little belatedly, Volume 39 for the year 2005. Vol. 39.3 (Fall 2005) featured Mary Piercey's survey of "Gender Relations in Inuit Drum Dances" and Rika Ruebsaat's thought-provoking "Pourquoi Chanter? An Experiential Look at the Québecois' Relationship to Singing". Vol. 39.4 (Winter 2005-06) had a British Columbia focus that included Norman Stanfield's piece on "May Day in New Westminster, B.C." and Jon Bartlett's "Fiddle Teaching in Vancouver", as well as Lorne Brown's reminiscences in "Gramophones, Virtual and Real".

Two issues of Volume 40 (2006) have so far made it through the press, and the third is in hand. Vol. 40.1 (Spring 2006) featured Kim Kobayashi's article on "Gender Issues within Canadian Kumi-Daiko" and David Gregory's article on "The Victorian Rediscovery of Vernacular Song", both of which were reworked versions of papers delivered at the 2005 CSTM conference in New Westminster. Vol. 40.2 (Summer 2006) had a Newfoundland focus, the two featured articles being David Gregory's "Vernacular Song, Cultural Identity, and Nationalism in Newfoundland, 1920-1955" and Terry McDonald's "Proud To Be An Islander: Newfoundland Identity Revealed through Newfoundland Song". All four issues carried regular columns, including Rosaleen Gregory's "Singing the Child Ballads" and John Leeder's "Treasures from our Archives", as well as many book and CD reviews.

We said in last year's report that there had been no lack of good contributions flowing into the magazine. The situation has not been so favourable this year, and the fact that we have printed two articles by one of the editors is a reflection of this fact. We attribute this in part to the fact that David enjoyed a sabbatical leave from Athabasca University which meant that he was in Europe at the time of the Congress of the Humanities and Social Sciences and did not attend the annual conference of the Folklore Studies Association of Canada. In previous years FSAC conference presenters have been a good source of material for *Canadian Folk Music* and this year that source has gone dry. Also some people (who shall be nameless) have promised articles but failed to deliver them.

Vol. 40. 3 (Fall 2006) will be out before Christmas and will feature an extended review of the new Peacock collection CD-ROM. We are still waiting anxiously to see the revised edition of Phil Thomas' *Songs of the Pacific North-West*, around which we expect to build an issue on the folksongs of British Columbia. This may be Vol. 40.4 or perhaps Vol. 41.1. Marcel Bénéteau has agreed to co-edit an issue on Franco-Ontarian songs at some point in 2007, and we hope that this will go some way to filling what is currently a glaring gap in the literature on this neglected subject. We would love to have more Québecois content, and more on the folk music of the Maritimes. We still lack an editorial board member from the Canadian north or from one of the Canadian aboriginal communities. Any volunteers?

One general note on editorial policy to conclude. CSTM has always been an alliance of ethnomusicologists, folklorists, musicians, and informed (but non-academic) enthusiasts for traditional music. Since we began editing what was then known as the

Bulletin we have tried to find a balance between printing feature articles of interest to musicologists and folklorists and including material (tunes, song-texts, and reviews as well as articles) that will interest those of our members who sing, play, and/or study Anglo-Celtic traditions in both Canada and the Old World. We think it is important to continue this policy of being as ecumenical as we can, although ultimately the contents of Canadian Folk Music reflect what our contributors choose to write about. Please keep those contributions coming!

Canadian Journal for Traditional Music: Editor's Report

Volume 32 [2005] of the Journal is underway. The Journal copy should be ready to submit for printing by the beginning of March, 2007, and the issue can be mailed out with the next issue of the Bulletin, as per last year. The plan is for four or five referred articles on topics including aspects of identity in Kathak—North Indian Dance, Vera King—one of Edith Fowke's informants, an ethnography of a Mi'kmaw powwow, and historical and social perspectives on the tambourine. In addition to these articles, there will be two or three book reviews.

Given the financial limitations of CSTM, I will do my best as Journal Editor to produce an issue in the range of 60 pages. While a Journal length of the issue from two years ago [80 pages] is preferable in my opinion, especially if the Journal remains an annual publication, I recognize that the Society simply cannot afford to produce Journal issues of that many pages. That said, a Journal of much less than 50 pages is not worth the effort, and worse, does not make for a creditable scholarly result. In the last two issues, a smaller font and some creative layout strategies helped to cut down the length from over 80 pages to 60 pages.

As I have mentioned in each of my reports from the past two years, it remains a struggle to generate serious interest in the Journal. I spend considerable amounts of time persuading possible contributors that the Journal is a serious, worthwhile venue for publishing their work. I would appreciate help from the Society executive and wider membership in spreading a positive message about the Journal, and directing possible publishable texts to me. Recent issues of the Journal demonstrate the broad approach we have taken to "traditional" music studies in Canada, as shown in the publication of articles on popular music topics, and the musical ethnographies of Canadians working in transnational contexts. An important point that should be emphasized in recruiting articles for the Journal is the fact the Journal is refereed, an aspect that appears to be forgotten, at least at times.

In 2007, I would like to apply for SSHRC funding from the Aid to Research and Transfer Journal program to support the Journal. This competition is every three years, and the next round is in 2007. If successful, the Journal probably would have to become bi-annual rather than annual, putting an added onus on the editor, the recruiting of high quality articles and reviews, and the production of the Journal. This does not mean that we should hesitate pursuing this funding route. Rather, SSHRC funding for the Journal could create an exciting new beginning for the Journal as the Society enters its next 50 years.

As we discuss these plans, it is important to consider both the Journal and the Bulletin as publications of CSTM. Each serves a vital purpose and, together, both articulate the multiple voices of the Society's membership and wider communities.

Membership Secretary's Report

There were 0 new institutional memberships added which, with deletions, gives a net change of minus 5. See Table 3.


The overall net change is minus 18. Note that this represents nearly 10% of the paying members. This year continues the downward trend in membership of last year, and indeed of the last 19 years. This report also contains a summary of members with their post-secondary affiliations. See Table 4.

The long term membership trend is shown in Table 5 and the associated graph. The figures in this report are comparable to last year's figures, but slightly high when compared to prior years. Memberships only paid to the end of 2005 have not yet been deleted, and while many of these will renew, there will be deletions.

International Council for Traditional Music: Report

I continue to send CSTM / SCMT notices to the ICTM Bulletin. ICTM meets every two years so there was no general meeting to report on for 2006. In 2004 at the ICTM Study Group for Music in the Mediterranean, I was invited to give a talk on my work on Alan Lomax's recordings in Ibiza and Mallorca: that was, sadly, Tullia Magrini's last meeting. I have been asked to contribute to

a memorial volume. This past August, Irene Markoff, Louise Wrazen, and I gave papers at the ICTM Study Group on Music and Minorities meeting in Varna, Bulgaria.

CSTM/SCTM is a National Committee of ICTM, and I attended the 8th Meeting of the ICTM Assembly of National and Regional Representatives at the University of Sheffield, 3-10 August 2005, in place of our then President, Norman Stanfield. A detailed report of this meeting may be found on the CSTM website. Meetings are held every other year, so there was no 2006 meeting.

The ICTM secretariat is now in Australia, hosted through 2008 by the Australian Musicological Society, Australia National University. Adrienne Kaeppler is currently President, Allan Marett Vice President, Stephen Wild, Secretary General; Don Niles, General Editor of the Yearbook for Traditional Music.
