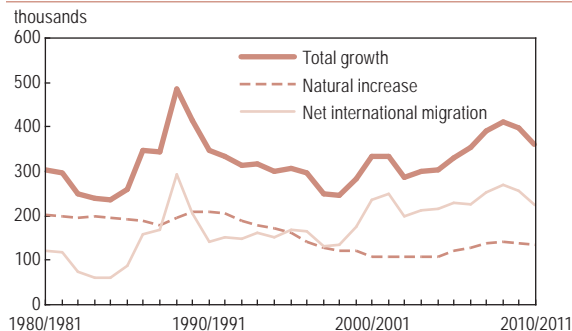

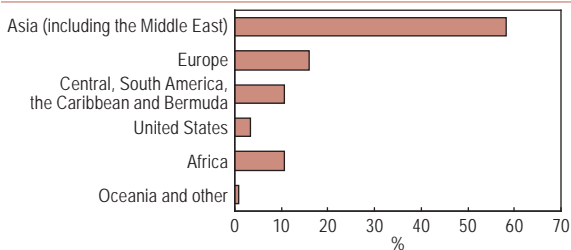

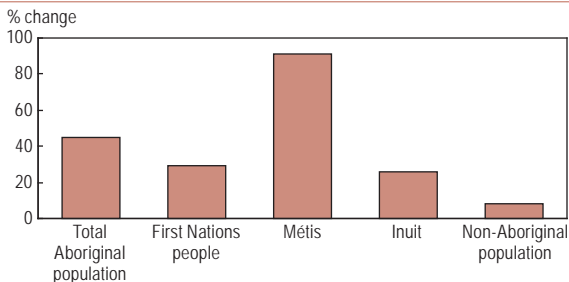

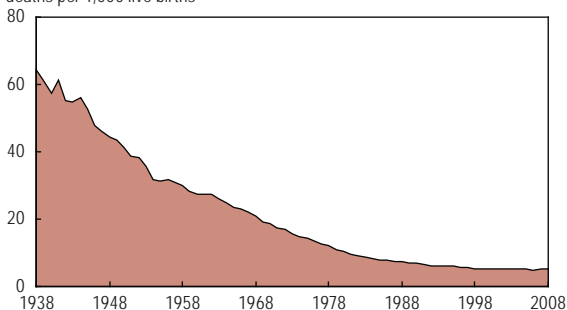

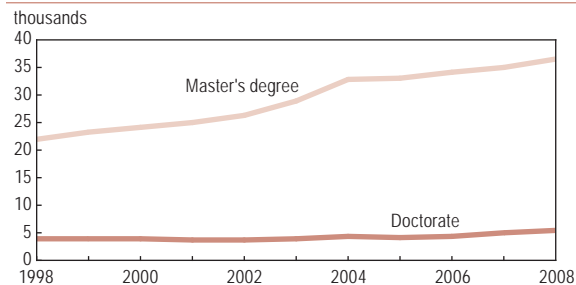

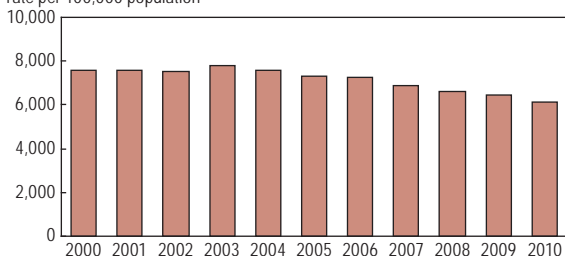
Graduate degree recipients from Canadian institutions

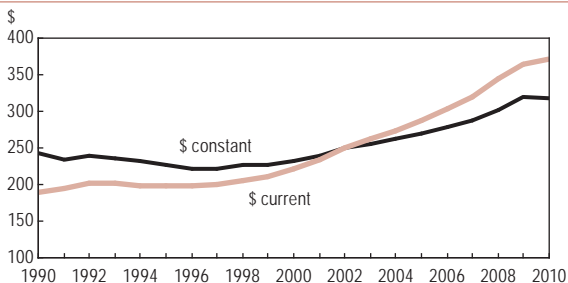

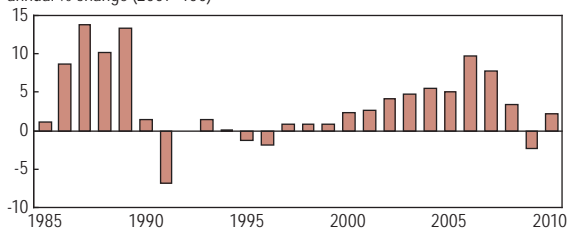

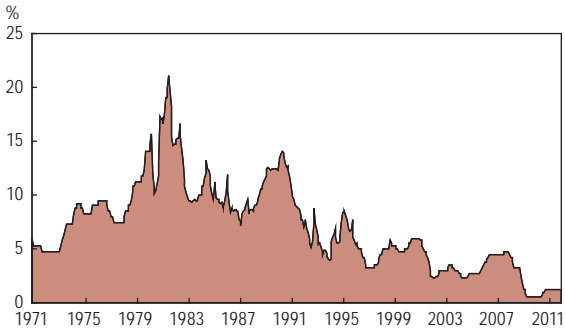

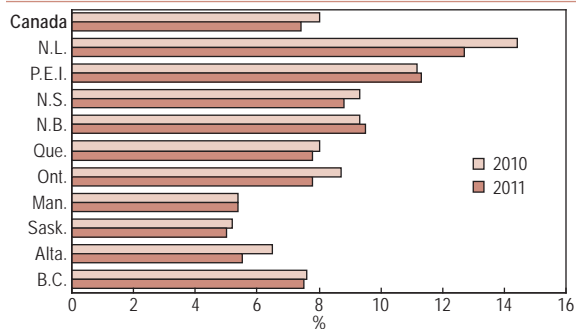

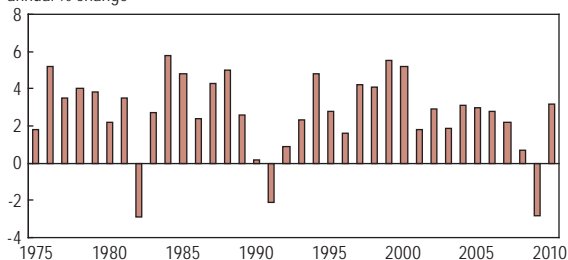

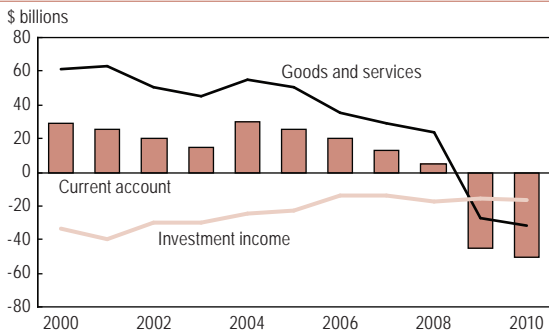

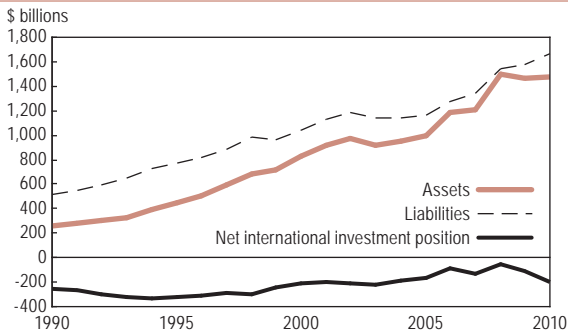

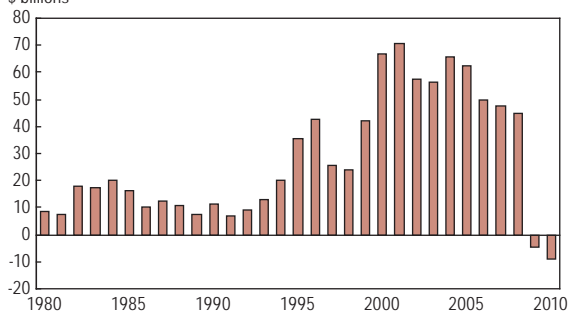

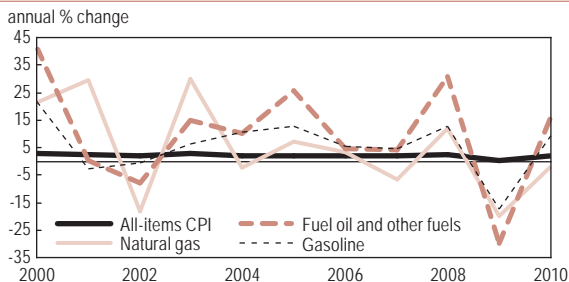

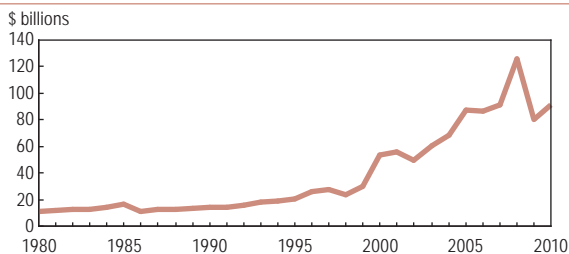

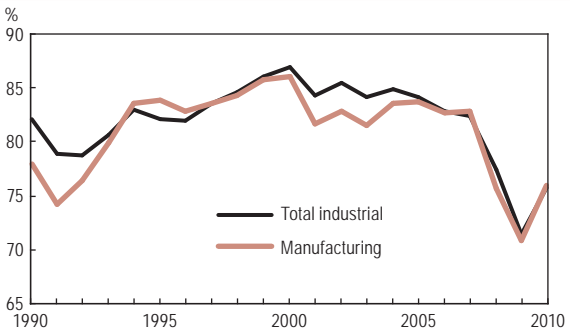

Industrial capacity utilization rates

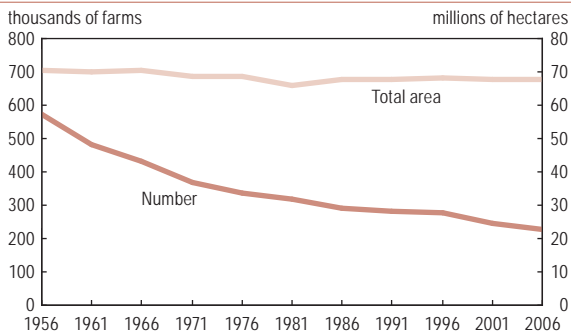

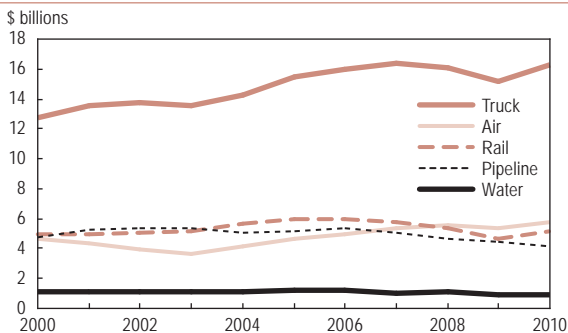

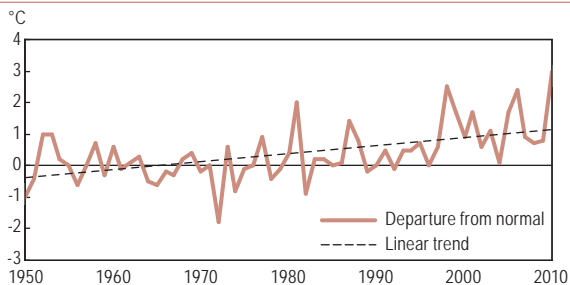

Mean temperature departures



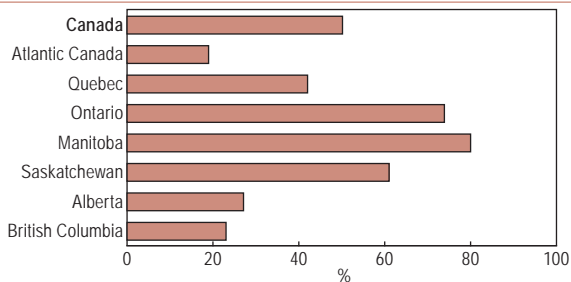
