Introduction

This is the fourth update of the *National Inventory of Treatment Programs for Child Sexual Abuse Offenders*. It is one of a series of directories prepared by the National Clearinghouse on Family Violence under the Federal Family Violence Initiative.

This updated directory provides a current listing of 196 programs that address the needs of child sexual abuse offenders. The programs are listed by province/territory from the east to west coast and, within each province/territory, alphabetically by town or city.

Each listing describes the program's target group, identifies how an offender is referred to the program, and indicates whether bilingual service is available.

The contact information provided in each listing may include: street or mailing address; administrative telephone number; crisis telephone number; facsimile number; E-mail address; and web site. Some listings also include a toll free number, which is generally accessible only within the local calling area. However, the toll free numbers for the National Clearinghouse on Family Violence can be used across Canada.

Please note that we have not attempted to evaluate the services in this directory.

Introduction

Ceci est la quatrième mise à jour du *Répertoire national des programmes de traitement pour les auteurs d'agressions sexuelles sur les enfants*. Il fait partie d'une série de répertoires préparés par le Centre national d'information sur la violence dans la famille, dans le cadre de l'Initiative de lutte contre la violence familiale lancée par le gouvernement fédéral.

Ce répertoire présente une liste à jour de 196 programmes qui répondent aux besoins des auteurs d'agressions sexuelles sur les enfants. Les programmes sont énumérés par province et territoire, d'est en ouest, et, dans chaque province et territoire, dans l'ordre alphabétique des municipalités et des villes.

Chaque description indique le groupe cible du programme, la façon dont les auteurs d'agressions sexuelles sont dirigés vers le programme et si des services bilingues sont disponibles.

Les renseignements fournis pour chaque inscription peuvent comprendre l'adresse civique ou postale, le numéro de téléphone administratif, le numéro de téléphone d'urgence, le numéro de télécopieur, l'adresse de courriel et de site Web. Certaines inscriptions comprennent également un numéro de téléphone sans frais, qui n'est habituellement accessible que dans la zone d'appels locaux. Toutefois, les numéros sans frais du Centre national d'information sur la violence dans la famille peuvent être utilisés partout au Canada.
