

MRSA and VRE 2007 Questionnaire Instructions

Please find attached the MRSA and VRE 2007 questionnaires, which should be used as of January 1, 2007. Please ensure that the appropriated person(s) in your facility have these forms.

The forms have been updated as per discussions at the breakout session and presentations at the 2006 CNISP meeting in Toronto. The following should be noted:

For MRSA surveillance

MRSA questionnaires:

Starting January 1, 2007 all "newly identified" MRSA cases are to be entered directly into the WEBBS system. Both colonized and infected cases should have questionnaires completed on them. Entry should be done is a timely manner, preferably at least on a quarterly basis.

AND

MRSA laboratory isolates:

As previously done only "clinical isolates" are to be sent to the National Microbiology Lab (NML) as described in the MRSA protocol. ICP are to set up a system in which they can communicate to the lab which isolates are the clinical ones to be sent to the NML. No colonized isolates are to be sent to the NML.

For VRE surveillance

VRE questionnaires:

Both colonized and infected VRE cases should have questionnaires completed on all "newly identified" VRE cases. Questionnaires should be submitted in paper form to Katie Cassidy until the WEBBS system is set up for VRE. Plans for VRE WEBBS submission to begin is July 1, 2007.

AND

VRE laboratory isolate (NEW!):

Only "clinical isolates" for VRE are to be sent to the NML. Since colonized isolates WILL NOT be sent it is important that question 15 on the questionnaire is completed (VRE genotype).
