MINISTER FRULLA SPEAKS ABOUT CANADA'S POSITION ON UNESCO'S CONVENTION ON THE PROTECTION OF CULTURAL CONTENT AND ARTISTIC EXPRESSION

On May 16, Minister of Canadian Heritage Liza Frulla hosted a meeting with 65 foreign ambassadors to explain Canada's position on, as well as strengthen the international community's support for, the UNESCO Convention on the Protection of the Diversity of Cultural Content and Artistic Expression. "The strength of a strong Canadian identity is based on having the means to develop our own forms of cultural expression," said Minister Frulla. In recent months, the UNESCO member countries, including Canada, have been at work developing the text of the Convention. A new draft of the text was published recently, and will be discussed again during the third session of the intergovernmental meeting on the draft Convention, to be held in Paris from May 25 to June 4, 2005. The text of the Convention is scheduled to be presented at UNESCO's next General Meeting in October 2005.
