Broadcasting Public Notices 2006-58, 2006-78, 2006-96 and 2006-112

Applications no 2006-0196-5, 2006-50667-6, 2006-0823-4 and 2006-0983-6: Applications by Rogers Cable, Bell, Telus and Vidéotron to amend the licences of their respective distribution undertakings to distribute satellite radio services on their digital cable service

Over the past two months he Canadian Conference of the Arts (CCA), alongside other industry organizations including CIRPA, SOCAN, ACTRA and others, has intervened against applications no 2006-0196-5 and 2006-50667-6, made respectively by Rogers Cable and Bell, to amend the licences of their respective distribution undertakings and be authorized to distribute satellite radio services on their digital cable service. The CCA now wishes to intervene against two similar applications (2006-0823-4 and 2006-0983-6), this time by Telus and Vidéotron.

Given the possible flurry of such applications, the CCA and the co-signatories of this letter ask the Commission to consider that the interventions they have already tabled with the Commission, either individually or collectively, as having also been made against the Telus and Vidéotron applications and against any other such application the CRTC may receive from any other Broadcasting Distribution Undertaking (BDU).

Considering the position taken by Bell ExpressVu, and now by Telus, that Direct to Home BDUs are already authorized to distribute Satellite Subscription Radio (SSR) if they so choose, the CCA and all co-signatory parties to this intervention respectfully request that the CRTC not proceed with any such applications without having first held a public hearing on the

fundamental issues raised by these applications concerning CRTC Canadian content regulations. We believe that such regulations have played and should continue to play a crucial role in achieving the objectives of the *Broadcasting Act* and that, in keeping with the 1991 Act, they should be applied in whatever appropriate fashion to all distribution undertakings irrespective of the technology used.
