

## **SECTION III - Health Information**

I, the undersigned Official Veterinarian duly authorized by the Government of Canada hereby certify that after due enquiry and to the best of my knowledge and belief the animal identified above complies with the following conditions:

- 1) The animal originates from Canada, a country in which no case of glanders, dourine, African horse sickness, epizootic lymphangitis, Venezuelan equine encephalomyelitis, St. Louis equine encephalomyelitis, contagious equine metritis, and vesicular stomatitis has been reported during the two (2) years immediately preceding the date of departure.
- 2) a) Canada has been free from trypanosomiasis for the past twelve (12) months immediately preceding the date of export.
  - b) The horse had resided in a province for the past three (3) months where no case of equine encephalomyelitis or vesicular stomatitis has occurred in the past twelve (12) months.
  - c) The horse has been kept on a premises where no case of equine viral arteritis has occurred for the past thirty (30) days prior to the date of export.



- Each animal has been examined within forty-eight (48) hours of export and found to be healthy and free from clinical signs of any infectious or contagious disease including glanders, epizootic lymphangitis, ulcerative lymphangitis, dourine, horse-pox, sarcoptic mange, influenza, ringworm, strangles, infectious equine anaemia, equine encephalomyelitis, vesicular stomatitis and equine viral arteritis.
- 3) The horse has been tested in a laboratory approved by the government of Canada for the following diseases:
  - a) equine infectious anemia immunodiffusion (Coggins) test with negative results within thirty (30) days preceding export;
  - b) equine viral arteritis serum neutralization test with negative results at a dilution of 1 in 4 within ten (10) days preceding export.
- 4. a) To the best of veterinary surgeon's knowledge and belief, during the three (3) months immediately preceding export, the horse has not suffered from any of the diseases listed below, has not been on any premises on which these diseases have occurred, nor had the horse otherwise been exposed to the risk of infection with these diseases:

equine infectious anemia, equine viral encephalomyelitis, Venezuelan/Eastern/Western equine encephalomyelitis, rabies, scabies, anthrax, glanders, dourine, strangles, epizootic lymphangitis, ulcerative lymphangitis, equine rhinopneumonitis, equine viral arteritis, babesiosis (piroplasmosis), Getah virus infection, or any other disease of equines notifiable in the country.

b) The horse has not been vaccinated with any vaccine within one (1) month of the date of shipment.

## **Declaration of Captain of the Aircraft**

A declaration from the captain of the aircraft or master of the ship in which the horse was carried stating that:

- the animal embarked at a port in USA or Canada and had not landed at any intermediate port during the flight/voyage to Malaysia. Stopovers of aircraft at Honolulu and Japan may be permitted, or any other port, as approved by the Director General of Veterinary Services, Malaysia.
- ii) no other animals were carried in the aircraft or ship during the time that the horse to which the certification refers are on board the aircraft or ship.
- iii) no fodder other than from the country of origin was carried in the aircraft or ship during the time that the horse was on board the aircraft or ship.
- iv) the interior of the aircraft has been sprayed with an approved insecticide just prior to the departure from the airport.
- NOTE: Should any outbreak of a major epizootic disease occur on board the aircraft or ship, the horse shall be returned to the country of origin or be destroyed and disposed of appropriately.
