IV. HEALTH CERTIFICATION

I, the undersigned official veterinarian, duly authorized by the Government of Canada, certify that the animals described below meet the following requirements:

1. Canada has been free from foot-and-mouth disease (FMD), rinderpest, contagious pleuro-pneumonia, vesicular stomatitis, and bluetongue for the past twelve (12) months. Vaccination against these diseases is prohibited in Canada.
2. The exported animals:
 - i)* were born in Canada and have been there since birth;
OR
 - ii)* they were imported more than six (6) months ago from a member State of the European Union (EU);
OR
 - iii)* they were imported from a third country that is included in the list of the annex of the Commission Decision 79/542/EEC, bovine cattle category, in compliance with the veterinary conditions that are at least as strict as the requirements defined in this Decision.

3. The animals have been examined today and do not show any clinical signs of disease.
4. The animals come from herds in which no restriction measures are applied under Canadian legislation concerning eradication of tuberculosis;
5. The animals come from herds in which no restriction measures are applied under Canadian legislation concerning eradication of brucellosis; they are not vaccinated against brucellosis.
6. The animals are not subject to culling under the national contagious diseases eradication program.
7. The animals have been at the holding of origin for the past thirty (30) days, or if they are less than thirty (30) days old, since birth.
8. The animals come from holdings where there is no proof of the occurrence of :
 - anthrax in the past thirty (30) days;
 - brucellosis in the past twelve (12) months;
 - tuberculosis in the past six (6) months;
 - rabies in the past six (6) months.
9. No veterinary legal measures apply to the holding of origin.
10. The animals being exported to the Netherlands were kept isolated from animals of different health status from the moment the first test mentioned in this certificate has been carried out, under conditions approved by an official veterinarian.
11. During the thirty (30) days preceding shipment, the animals were tested with negative results for the following diseases:
 - i) tuberculosis, intradermal tuberculin test according to the Canadian standards;
 - ii) brucellosis, serum agglutination test with a titre less than 30 I.U;
 - iii) enzootic bovine leukosis, serological test (AGID or ELISA);
 - iv) foot and mouth disease, serological test (ELISA).
12. The animals were transported directly from the isolation premises on the holding of origin to the port of exit without contact with animals of lesser health status, in previously cleaned and disinfected vehicles and were loaded for export into crates that were new or previously cleaned and disinfected.
13. The transport of animals complies with the Canadian transportation Regulations and International Air Transportation Association (IATA) with reference to Directive 91/628/EEC.
