I hereby certify that:

1. The semen was collected from a boar maintained in an artificial insemination centre which is under Official Veterinary supervision of the CFIA.
2. The donor boar is registered in the recognized herd book of the breed in Canada and:
  - a) was born in Canada, or has been continuously resident in Canada for a minimum of twelve (12) months and fully complies with the Canadian semen donor boar health testing standards;
  - b) was born from descendants free from hereditary diseases.
3. Canada is officially recognized to be free from foot and mouth disease, vesicular exanthema, swine fever, African swine fever, swine vesicular disease and Aujeszky's disease.
4. The donor boar was in good health and free from all signs of infectious or contagious disease, at the time of collection of the semen.
5. The donor boar and all other animals resident in the approved semen production centre have been subjected to test within six (6) months prior to the date of shipment and found to be free from:
  - a) tuberculosis
  - b) brucellosis
  - c) leptospirosis
  - d) transmissible gastroenteritis
  - e) Aujeszky's disease

- i) At least forty-eight (48) hours notice of arrival of the semen must be given to the Director, Veterinary Services, Hope, Jamaica, by the importer.
- ii) The consignment of semen and the accompanying veterinary health certificate are subject to veterinary inspection on arrival.
- iii) Semen must be accompanied by an import permit from the Director of Veterinary Services, Jamaica.
