Subject: Fish Collection Permit

Hi Barb: Please find attached below a request to sample fish in the Fraser River at Tranmer Bar and area on Dec 17th, 2010. The work will be done by the Fraser River Gravel Stewardship Committee. We have been given a short notice opportunity to an air boat that can be used to undertake this work thus this request. Key to the work is an undertaking of examining the extent of Maria Slough sockeye salmon juvenile rearing on Tranmer Bar. (In our sampling of 2007 we noted extra-ordinary numbers of juvenile sockeye rearing on Tranmer.) This run of sockeye is probably the most unique in all of British Columbia insofar as it is both a river rearing fish, spawns in a side channel of the Fraser River, and reproduces in January/February. The data, of course, will be used as part of the input for comments relating to the Tranmer CEAA authorization, and will also be presented to Judge Cohen vis a vis the gravel issue.

I understand if you cannot turn around this request by the 17th December but would appreciate if you can. We are also hoping that Jason Hwang will help facilitate this exercise by expediting the permit. I have cc'd him in this regards.
