

NEGOTIATION MANDATE

NAME: **CARRIER SEKANI TRIBAL COUNCIL**

POPULATION: - 4,269 - 7 on Fraser R. watershed (including non-F.R.=4,942)

LAST YEAR:

- Funding: - \$175,000. (plus \$75k C.E.D.P. chinook hatchery)
- Allocation:
 - Sec. 35 - no specified allocation
 - Sale - none agreed to

1993/94 REQUESTED:

- Funding: - \$798,000.
- Allocation:
 - Sec. 35 - None to date - to be negotiated with each band.
 - Sale -300 sockeye (Stoney Creek Band)-part of a prepared meal to feed 1,000 people (proposal associated with the City of Vanderhoof).

RECOMMENDATION:

- Funding: - \$650,000.

The majority of this would be used to fund fish habitat related projects and adult salmon escapement enumeration. **Regional DFO staff have not had an opportunity to meet with the newly formed CSTC Fisheries Commission - justifiable proposals to date total \$500,000.**

Enforcement - 3 guardians; monitoring - 5 catch monitors.

- Other Funding Sources Recommended:

-Nak'azdli Band - existing C.E.D.P. chinook hatchery \$77,000.
-Nadina Spawning Channel -Existing DFO (SEP) operations -potential AFS tsf.

- Integration with other branches:

-Science - bedload movement study - Middle R. streams (39k)
-Science - Driftwood R. - escapement research (12k)
-Science - Water Temp. Monitoring Program -3 sites (13.5k)
-Management biology - fence operations Middle R. - adult sockeye enumeration.

- Allocation:

- Section 35 - 50,000 sockeye & 100 chinook (6 bands fishing Nechako watershed)
 - Sales - 300 sockeye (part of meals sufficient to feed 1,000 people at Vanderhoof).

NAME: LHEIT-LIT'EN NATION (one Band)

POPULATION: 202

- Funding: \$75,000.

 - Sale - None agreed to

1993/94 REQUESTED:

- Funding: 922,900
- Allocation:
 - Sec. 35 - 31,940 salmon
 - Sale - 3,200 sockeye (Pow Wow and Elders Fish Camp meals).

RECOMMENDATION:

- Funding: \$150,000

Two Native guardians will be hired jointly with DFO and MOE to employ them for as much of the year as possible. In order to employ the two guardians for a longer period of time, as many field projects as possible will be assigned to these people, including catch and escapement monitoring, habitat protection work and enforcement.

-Science - Water Temp. Monitoring Program -3 sites (4.5k)

- Allocation:

- Section 35 - 6,000 sockeye & 400 chinook
 - Sales - 3,200 sockeye (Pow Wow and Elders Fish Camp meals). The elders fish camp will involve tourists from Prince George visiting the scenic Red Rock Canyon fishing site by jet boat and bus. Visitors will be able to view harvesting by gillnet and a fish wheel and then enjoy a Native cultural program, including a meal, on an island immediately upstream.

RECOMMENDATION:

- Funding: \$40,000.
 - This would employ two guardians/monitors, who would focus and catch and escapement monitoring.
- Other Funding Sources Recommended: None
- Integration with other branches:
 - Science - Water Temp. Monitoring Program -3 sites (9.k)
- Allocation:
 - Section 35 - 8,500 sockeye (less than 100 chinook)
 - Sales - No request anticipated

- Funding: \$328,090
- Allocation:

 - Sale - None to date but indicate band members will be selling.

RECOMMENDATION:

- Funding: \$200,000
- 3 Native guardians would be hired for catch and enforcement monitoring, plus 6 technical trainees for catch and escapement programs.
- Other Funding Sources Recommended: None
- Integration with other branches:
 - Science - Water Temp. Monitoring Program -3 sites (4.5k)
- Allocation:
 - Section 35 - 90,000 sockeye; 500 chinook (These catch figures represent the combined catch numbers for the Mid Fraser Basin Shushwap (Cariboo Tribal Council and Tsilhqot'in Tribal Council.)
 - Sales - None recommended unless small quantity requested as part of a meal.
