**1. Wild Salmon Policy Web Mapping Application (*Decision*) – R.Reid (H. Stalberg and Dwight McCullough)**

**Issue:** OHEB presented an update on the work they have done in creating a web mapping portal for the WSP. The presentation included a request for three-year funding, to be shared equally by OHEB, Policy, FAM and Science.

**Next Steps:** RMC felt that while the initiative is useful, it is difficult to make a funding decision out of context and that it would be helpful to have a broader understanding of other WSP work and initiatives that might require funding.

Policy was asked to lead on a discussion of the array of WSP initiatives, especially those that require funding outside of the lead branch, with the objective of setting priorities for funding. This discussion should occur at the appropriate RMC Committee.

**2. Implementation of the Operations Committee (*Decision*) – A. Bate for A. Webb**

**Issue:** Although it was approved in January 2007, the Operations Committee has yet to be formally implemented. The purpose of this item was to seek approval of the Terms of Reference.

**Next Steps:** The proposed Terms of Reference were approved with minor changes and do not need to return to RMC. The list of proposed subjects for discussion at the Operations Committee was also approved, with the understanding that it would be revisited on an annual basis. The RDG noted that judgment of RMC members would be required to determine which RMC sub-committee would be the appropriate forum for discussion.

### **3. Guidelines and Process for Appointments to the Pacific Salmon Commission Panels (*Discussion*) – P. Macgillivray**

**Issue:** Pacific Region is developing a new process and guidelines for appointments to the Pacific Salmon Commission (PSC) Panels.

**Next Steps:** RMC members agreed on the approach with some minor adjustments to clarify the process and accommodate differences with the Transboundary Panel in the Yukon.

P. Macgillivray was asked to return to RMC at a later date with an approach to managing Technical Committee memberships.

### **4. Mandatory Use of Automated Section 52 Licence Issue System (*Information*) – S. Farlinger (Roy Neighbor)**

**Issue:** Licences issued under Section 52 of the *Fishery General Regulations* require close control and monitoring to ensure they are issued consistent with the Court's guidance in *Larocque* and *APPPA*. In Pacific region, most Section 52 licences are issued manually, reducing control and oversight opportunities and potentially increasing legal risk for the region. A process to automate issuance of these licences is proposed. A working group has been established to develop the process.

**Next Steps:** Questions were raised about the expected cost of this initiative, but it was accepted that there is no choice but to continue due to the legal requirements. Once the tool is developed, it could potentially be used for other applications, e.g., issuance of communal FSC licences.
