Explanation of headings under the ‘Other Evidence’ column: “ <u>No</u> ” means that other evidence (as defined on page 22) <u>was not available</u> for the listed stressor from either the PSC or Cohen Commission reports; “ <u>Yes</u> ” means that other evidence <u>was available</u> for the listed stressor from these reports and provided additional support <u>for</u> the hypothesized stressor; “ <u>Against</u> ” means that other evidence <u>was available and was contrary</u> to the hypothesized stressor; and “ <u>Mixed</u> ” means that other evidence <u>was available, some supporting and some negating</u> the hypothesized stressor.
