I have come across a situation that requires your advice/direction please.

Eric has a number of sites that he wishes to coordinate onsite visits with DFO Area Bios (most sites are proposed for Broughton). I immediately jumped at the opportunity to visit the one proposed site in "my area of responsibility", Shaw Point in May. However in retrospect, I perhaps jumped too soon?

I believe a standard letter has been sent for Shaw Point to Transport Canada as this is one of the Renewal Sites? (Allison, I don't have a copy of the letter to TC but assume one was sent?) The standard letter lists mitigation measures and states that: *project as proposed, is not likely to result in significant adverse effects on fish and fish habitat providing the following mitigation...*

This site was modelled using DEPOMOD and a 15 g, 10g, 5g and 1g contour was illustrated. The resuspension module was On.

I am somewhat uncomfortable conducting "compliance sampling" (as Eric is calling it) with the province for this renewal site without senior level support and direction.

Thanks for your direction in this matter. I will hold off committing to a compliance sampling schedule until I hear back from you.

Both times are fine but if possible the 9-12 timeline is best if possible (but I can be flexible either way).

We do **not** have an Authorization for Shaw Point as this is one of the Renewal applications in which DFO submitted a standard mitigation letter to Transport Canada to consider in their CEAA screening report.

However, we do have a DEPOMOD model output for this site.

Before committing to the sampling of Shaw Point, I wish to first seek direction from senior management.

I will get back to you ASAP! Again thanks for the invite.
