It is not one of the positives of AVC (GFC: heart-3; AVC: heart-11, gill-2 and -10)

According to our policy, we are reextracting it.

Crystal: when ready, please run the first cDNA and the 2nd cDNA (reextraction).

I am not convinced it should be reported to our friends in Ottawa, guess why !

We do not like to see a Ct like this, but this is the type of Ct that is equivalent to the finding by Nylund, i.e. can't conclude anything from it
