I think that it is appropriate to counter the link with northern cod. However, I would be somewhat cautious about again repeating the work that Simon had done on small pink salmon in the lab. This is because the field situation could be quite different with, for example, multiple infection periods, and with sockeye. The stronger message would be poor returns elsewhere on the coast (if the data still suggest this).
