Modernization of the Policy for the Management of Fish Habitat

- The 1986 Policy for the Management of Fish Habitat (Habitat Policy) provides a framework for the administration of the habitat protection and pollution prevention provisions of the *Fisheries Act*
- The Habitat Policy is the basis for the Habitat Management Program, though much has changed and much has been learned since its introduction
- Internal discussions are underway to determine whether modernization of the Habitat Policy will be undertaken
- Many partners and stakeholders will have interest in the modernization of the Habitat Policy and will be engaged early in the process to help inform its development

The Policy Agenda

- The Habitat Management Program has identified several priority areas for development and improvement of operational policies:
 - Position Statement on Fish Mortality
 - Policy on 'No Net Loss' and habitat compensation guide
 - Guide to writing authorizations
 - Marine Pathways of Effect and space-based management
 - Guide on Flow Requirements
- Consultation with provincial partners is vital to developing strong policy documents
- A process is needed for informing provincial agencies of new policy work, and for obtaining technical input on their development
 - The Position Statement on Fish Mortality as a pilot project

Habitat Management Partnering Arrangements

- The concept of partnering has been central to the delivery of the Habitat Management Program
- Canadian Council of Fisheries and Aquaculture Ministers (CCFAM) in early 2000 committed to signing formal Habitat Management agreements to meet its objective of *“Coordination of fish habitat management activities by governments to provide, efficient, seamless program delivery to Canadians”*
- In 2002, DFO approved internal “Guidelines for Developing Partnering Agreements on Fish Habitat Management with Provincial and Territorial Agencies” and has used these as basis for formal agreements with stakeholder groups as well

- Areas of focus:
 - Administration and enforcement of the *Fisheries Act*
 - Collaborative arrangements with provinces, communities, and stakeholders
 - Implementation and adaptation of the Environmental Process Modernization Plan
 - Performance measurement and reporting
- The Audit also looks at case examples:
 - Duck Pond Tailings Impoundment Area
 - Oil Sands
 - Fraser River Gravel
