This public-education component of CCD activity holds potential to assist in the information-gathering and interpretative aspects of the Commissioner's work.

Request for Funding

- m)The Coalition is not a charitable organization and, accordingly, is unable to solicit donations from the public using tax receipts.
- n) The Coalition has a limited budget comprised of contributions received from its members and other supporters. These monetary and non-monetary contributions are used to cover the expenses the Coalition incurs to run its national operations.
- As a largely volunteer-run not-for-profit organization, the Coalition does not have a budget other than for basic needs.

- p) The Coalition is an intervenor in the Air India Inquiry, for which status no funding was sought. The Coalition bears the burden of its Air India Inquiry operations, through the contributions of its members and other supporters.
- q) The Coalition is unable, through its present base of financial support, to fully fund its participation in two, contemporaneous commissions of inquiry.

Counsel

- r) The counsel selected by the Coalition is Ottawa-based lawyer, David B. Harris. Mr. Harris has acted for CCD at the Air India Commission and we have full confidence in his ability to effectively and efficiently act as counsel before this Commission.
- s) Mr. Harris is familiar with Treasury Board guidelines and the practice of keeping detailed, daily time entry dockets describing what work has been completed, by whom, and at what hourly rate. He has committed to providing the same detailed dockets for the Commission.

Use of funds

- t) The Coalition is only seeking funding for its necessary counsel fees and its necessary disbursements. The plan is designed to minimize expenses while ensuring that the Coalition is able to participate in the Inquiry, and to do so in such a way as to enhance the work of the Commission.
- u) The Coalition is seeking funding for its counsel to review the relevant documents filed with and disclosed to the Commission, to be of assistance to the Commission counsel by suggesting witnesses and areas of examination, to follow the daily proceedings by reviewing the daily transcripts and exhibits, and by preparing and delivering closing submissions. The Coalition is only seeking funding for the purchase of transcripts and copies of exhibits that are not otherwise available to it without cost, and is only seeking funding for its counsel to appear in person at the hearing when they will be otherwise unable to access the evidence.

Conclusions

- v) The Coalition does not have the funds to finance fully its participation before this commission and, due to the timing of this Inquiry, our commitment at the Air India Inquiry, and the limitations imposed by the Act, the Coalition has no alternative means of funding its participation. In the absence of a grant of sufficient funding, the Coalition is not expected to be able to participate in the Inquiry.
- w) The Canadian Coalition for Democracies has clearly ascertainable interests and perspectives that are essential to the Commission's mandate. In particular, the Coalition remains distinct among nongovernmental organizations active in national-security debates, for its capacity and inclination to take full account of the grave extent of the developing terrorist threat, including the menace of mass-casualty and mass-destructive attacks. The Coalition brings a rigorous and unsparing dedication to the principle that civil liberties can only truly be enjoyed in a peaceful and secure environment, and that strong, vigorous and accountable security and intelligence including effective international intelligence cooperation remains key to preserving that environment from the current peril.
- x) The Coalition respectfully asks the Commission to grant this application for funding. This Inquiry raises important issues in which the Coalition has a substantial and direct interest.
- y) The subject matter of the inquiry will affect the legal and property rights of Coalition's ethnically and religiously diverse membership. The Coalition as an organization actively engages in issues of national security, individual and human rights, discrimination, and advocacy regarding foreign policy, immigration and terrorism which are significant aspects of this inquiry.
- z) As described herein, the Coalition will bring a perspective that is unique and different from the parties and the other proposed intervenors in the inquiry and will present arguments which will be highly relevant and useful for this Commission in considering the issues thoroughly. For these reasons the Coalition's perspective should be heard at this Inquiry.

This affidavit is sworn in support of the Coalition's motion for funding to participate before the Internal inquiry into the Actions of Canadian Officials in Relation to Abdullah Almalki, Ahmad Abou-Elmaati and Muayyed Nureddin.
