

### AFFIDAVIT OF LESLIE McINTOSH

# I, LESLIE McINTOSH, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SWEAR AS FOLLOWS:

- I am counsel in the Crown Law Office Civil of the Ministry of the Attorney 1. General for Ontario. I am one of the counsel who represented the Ontario Provincial Police ("the OPP") in the Inquiry into the Actions of Canadian Officials in Relation to Maher Arar. The OPP were granted standing and participated at that Inquiry.
- This Internal Inquiry into the Actions of Canadian Officials in Relation to 2. Abdullah Almalki, Ahmad Abou-Elmaati and Muayyed Nureddin was established by Order in Council number P.C. 2006-1526, dated December 12, 2006, (the "Order in Council") which established the Commissioner's Terms of Reference.
- Pursuant to the Terms of Reference, the Commissioner shall determine: 3.
  - whether the detention of Abdullah Almalki, Ahmad About-Elmaati i. and Muayyed Nureddin in Syria or Egypt resulted, directly or

- indirectly, from actions of Canadian officials, particularly in relation to the sharing of information with foreign countries and, if so, whether those actions were deficient in the circumstances;
- whether there were deficiencies in the actions taken by Canadian officials to provide consular services to Ahmad About-Elmaati and Muayyed Nureddin while they were detained in Syria or Egypt, and
- iii. whether any mistreatment of Ahmad About-Elmaati and Muayyed Nureddin while they were detained in Syria or Egypt resulted, directly or indirectly, from actions of Canadian officials, particularly in relation to the sharing of information with foreign countries and, if so, whether those actions were deficient in the circumstances.
- 4. The OPP on its own behalf and on behalf of its current and former officers seek standing and all privileges and rights of participation in relation to the Internal Inquiry into the actions of Canadian Officials in relation to Abdullah Almalki, Ahmad Abou-Elmaati and Muayyed Nureddin, pursuant to the Terms of Reference for the Inquiry and Rules 8 and 9 of the Rules of Procedure and Practice established for the Inquiry.
- Members of the OPP belong to joint police task forces operating with the RCMP, which were involved in matters relating to the mandate of the Inquiry. These task forces are known as Integrated National Security Enforcement Teams (or INSET Teams).
- 6. As contemplated by the federal Security Offences Act, the INSET is charged with the investigation of offences arising out of conduct constituting a threat to the security of Canada. As members of these teams, OPP officers have information about actions and communications that took place among Canadian officials in relation to the mandate of the Inquiry.
- 7. The OPP and its current and former officers participated in the investigation about which this Inquiry is focused. In addition, various former and current OPP officers performed duties, both in the chain of command, and in investigative duties, within the investigation about which the Inquiry is focused.

- A number of current and former OPP officers may have knowledge of facts, events, policies and procedures that may be relevant to the mandate of the Inquiry.
- 9. Accordingly, these officers, both current and form OPP officers whose actions are the subject of this Inquiry and who have knowledge of the facts, events, policies and procedures that may be relevant to the mandate, have a substantial and direct interest in this Inquiry.
- 10. In addition, some of the documents and information that is relevant to the mandate of the inquiry may be in the possession of the OPP and its officers. This material and information may assist the Commissioner in carrying out his mandate.
- 11. OPP officers who are members of these INSET Teams may be supervised by the RCMP; however, they still remain subject to the authority of the provincial *Police*Services Act. The OPP therefore has a substantial and direct interest in the Inquiry as the employer of police officials who were members of an INSET Team that was involved in matters related to the mandate of the Inquiry.
- 12. The OPP has a substantial and direct interest in the nature and composition of the joint investigative police teams assigned to national security. The OPP has experience with joint RCMP/OPP investigative teams dealing with, for example, on the federal level, issues of national security and money laundering, and on provincial level, issues of organized crime.
- 13. The OPP has an interest in the institutional arrangements within which police officials participate in INSET Teams charged with investigating matters of national security. The OPP's knowledge of, and experience and interest in these matters will be important to the Commissioner in fulfilling his mandate.
- 14. As a provincial police service, the OPP maintains a particular perspective and/or expertise that may assist the Commissioner in discerning the complex factors affecting multi-jurisdictional joint force operations in the realm of national security.

- among police forces both at the domestic and at international levels for investigations relating to national security. The OPP therefore has a substantial and direct interest in the institutional arrangements that facilitate this sharing of information among police forces at the domestic and the international level, and its officers have knowledge and information relating to the context and the circumstances within which information is shared in INSET or other joint police forces.
- 16. In conclusion, the OPP requests standing before the Inquiry because it has a substantial and direct interest in the subject matter of the Inquiry in that:
  - (a) The OPP and its officers participated in the investigation about which the Inquiry is focused.
  - (b) OPP officers performed duties, both in the chain of command, and in investigative duties, within the investigation, about which the inquiry is focused.
  - (c) The Inquiry's findings and recommendations, like those made by Justice O'Connor, may impact the OPP and its employees.
  - (d) The Inquiry's findings and recommendations may impact the current and/or future role of the OPP and its employees engaged in national security investigations.
  - (e) As a provincial police service, the OPP maintains a particular perspective and/or expertise that may assist the Commissioner in discerning the complex factors affecting multi-jurisdictional joint force operations in the realm of national security.
  - 17. The OPP therefore seeks, on its own behalf and on behalf of its current and former officers, full standing before the Inquiry, with full opportunity to attend the proceedings of the Inquiry and if necessary, give evidence and/or cross-examine witnesses on matters relevant to the OPP's interests and that of its current and former officers, as outlined above.
