Commissioner O'Connor has been mandated to base his Policy Review recommendations on an examination of domestic and international models of review, as well as on an assessment of how a review mechanism would interact with existing review mechanisms.

The Commission has published a number of papers to assist with this process. These include the Consultation Paper, which lists a number of options for a review mechanism for the RCMP's national security activities; and background papers which canvass Domestic Models of Review of Police Forces, Accountability of Security Intelligence in Canada, and International Models of Review and Oversight of Police Forces and Security Intelligence Agencies. Additional background papers will be released by the Commission and will be posted on the website as soon as they are published.

In order to further public dialogue about these and other review options, and to assist in formulating his recommendations, the Commissioner has invited Canadian and international experts on models of review and oversight to participate in Roundtable discussions. The Roundtables will canvass the experts' observations on and/or experience with various review features and options.
