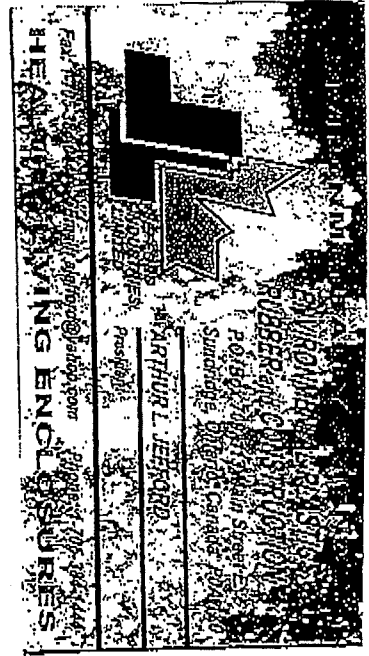

- e.1 **Arthur L Jefford from 1959 to the Present as one of 75 Canadian Boy Scouts representing Canada has represented Canada over one hundred times with more than half of these times as the Head of the Canadian Delegation and as such has first hand knowledge of how important just the slightest gesture can provide such a diferent meaning and message to others from different cultures and ethics are of the utmost importance in todays International Marketplace**

- e.2 At the age of 6 in 1948 my Maternal Grandfather said it was time my brother a year younger and my cousin a year older should know about business and the three boys with Grandmas and Dad's helpful advice contracted to do business and shingle one of my Grandfathers cottages. Successive summer school working during the holidays developed leadership, confidence and the value of good ethical business practice.
- e.3 Over the years I worked in the building construction industry in sales and marketing being project manager of many of Ontario and Quebec's high profile projects and gained the repulsive exposure into the hide it "Pay 2 Play" world of buying the job.
- e.4 In the late 1970's I incorporated my business ventures into one Jefford Industries Ltd. and actively participated in the Canadian Government Specifications Board and later as the Canadian Expert for the Minister of Industry in the Standards Council of Canada in I attended as the March 1980 Head of a Canadian Delegation to the International Standards Organization ISOTC61SC5 Plastics and took the business into Thermo Set Plastics for their dynamic fire resistance properties.
- e.5 In the late 1970's and 1980 with the Canadian Government Canadian Home Insulation Program (CHIP) Insulation Grant and as the Chairman of the Society of Plastics Industry (SPI) Phenolic and Urea Formaldehyde Committee (PUFF) I was thrust into the unbelievable battle of the lobbyist with the Canadian Development Corporation CDC vs CD Howe and the buying of Government and Lobbyist's favour for business success.
- e.6 Ultimately declining to "Pay 2 Play" the Government Minister of Health via the Minister of Consumer and Corporate Affairs Banned UFFI on the basis that;  
 (a) Testing done to Guarantee failure by testing below the ambient level  
 (b) Testing in a contaminated area of 267 other formaldehyde products emissions  
 (c) Testing in a different area from where the tested product was located  
 Testing inside a building enclosure for .001 ppm Formaldehyde  
 (when the ambient level was 4.0 ppm formaldehyde)  
 (where 267 other sources of formaldehyde were present in the area you were testing); and  
 that result would tell you how bad UFFI was on the outside of the national vapor barrier;  
 that separates the inside from the outside of the building enclosure;  
 testing in a completely different area from where the tested product was located
- e.7 The USA ban followed 6 months later but was overturned a year later as it should never have happened and all parties were compensated. The Canadian a \$100 million white wash Inquiry set the playing field and causal action for this and other Canadian scandalous inquiries with many of the same players but also started the ethics activities
- e.8 Canada's \$100 million dollar White Wash Inquiry that could never find its way to just understand the simple basics of e.6 above as "The Lobby Money Was Flowing"
- e.9 From December 17, 1980 I was so aggressive furious at the devastation wreaked upon my family that the Sharp 1983 concept of "Lawyer Loop Hole Ethics" was not acceptable but to understand the resistance just look at who the High Profile Politicians were at the time and compare the Names and Parties in the recent Scandle Inquiries. 1985 Conflict of Interest may be criticized for having many "Loop Holes" drafted within but to grow a tree you first have to plant the seed to start "The Tree of Thriving Life"

- e.01 I was so vocal at the time the local "Do Nothing MP" arranged to list me as mad enough to be a terrorist and lead to RCMP inquiries.
  - e.02 My \$120 Million dollar Companies disappeared over night and 1,005 Canadians lost their jobs and by March 5, 1981 a year after sitting down with Dr Rubex in the Intercontinental Hotel in Budapest talking of making this ingenious cube I had added up 3483 pending UFFI Litigation Actions for \$484 million a divorce family break up and custody of 4 young daughters to suffer PTSD
  - e.03 My layman litigation court room education started daily with night time mitigation work and court room next day preparation to actions in every level of Canadian courts The Lawyers, Real Estate, Construction Industry, all distanced themselves with fear they would be next if they didn't pay their sin tax to the influential official
  - e.04 When it comes to the impact of refusal to "Pay 2 Play" high profile Canadian Politicians I can provide the Inquiry with a clear view point of the high financial cost to the Canadians affected by "Bad Ethics Policy" and failure to look into this on this Inquiry any results would be seriously flawed
  - e.05 When it comes to the impact of refusal to "Pay 2 Play" high profile Canadian Politicians I can provide the Inquiry with a clear view point of the high cost to the Canadians on personal and family lifetime "Well Being" from "Bad Ethics Policy" that can be more devastating than wrongful convictions and imprisonment and failure to look into this on this Inquiry any results would be flawed
  - e.06 Failure of this Inquiry not to consider there are two sides to every coin or view point to perfecting a good performing ever evolving ethical policy any recommendations and results would be flawed
  - e.07 I verily believe that belief in my personal values of for example in 1981 with 4 young daughters who felt that the whole world was mad at them to exhaust all the mad anger we ran with the Etobicoke Track and Field Club but wanting to keep my young daughters clean and not be a "Cheatar" my daughter ran bronze behind the two Angela's and under pressure to be the best ultimately turned our back on Etobicoke and ran with the Oakille Track and Field Club and lost opportunity for the Olympics. In an inquiry to develop "Policy Review" a responsible Inquiry needs parties who were directly and substantially affected by the mandate of the Policy Review but all from the same view point yield a distorted result for failure to look at the other side of the coin
  - e.08 The reason for my application is that a "void in ethics" where "greed is king" does have a "fall out" that devastates all those who don't play the corrupt game and work the rules to steal from those of us who do believe in a "Fair Game Playing Field". In today's economic times nothing is more evident than the "Money men" tightening the reins for \$275 billion Canadian Bailout and a \$4 Billion existence time buy of taxpayer's money % fee funneled by accountable Politicians through Bankers on the marketed perception to save jobs and the poor tax payer now has to pay off this future debt to spin the recession all over again. Failure to have the Best Global "Ethical Policy Restructuring" will devastate every Canadian's "Well Being" and we will never develop Team Canada as those only looking

after them selves will just be too many anchors dragging us down the swirl of a horrifying economic black hole into oblivion with the powerful always skimming the big bucks


