### MOTION OF THE LIBERAL PARTY OF CANADA AND LIBERAL PARTY OF CANADA (QUEBEC) TO HAVE WITNESSES HEARD BY THE COMMISSIONER (ARTICLE 29 RULES OF PRACTICE)

- [1] The Applicants, Liberal Party of Canada and the Liberal Party of Canada (Quebec) (collectively "the Liberal Party") wish to have the Executive Directors of the Liberal Party, Mr. Steven Mackinnon and Me Hervé Rivet testify before the Commission.
- [2] The Applicants submit that the evidence that these two representatives would be relevant to the exercise of the Commission's mandate.   - d) The structure of the Federal Liberal Agency of Canada and its operations;

- The changes to the Electoral Financing and reporting e) regime occasioned by the adoption of Bill C-24 and the steps taken by the Applicants to implement this process:
- f) The measures put in place by the Applicants to ensure that the abuses and excesses identified in evidence before this Commission do not re-occur.
- [4] The Applicants expect that the presentation of this evidence would not extend beyond two hours.
- [5] The Applicants submit that such evidence is both useful and necessary to the accomplishment of the Commission's mandate.
